Accessing Your Account

Access the web page by clicking this link or typing it into your browser <u>https://www.compass.state.pa.us/cwis/public/home</u>

- This clearance can only be requested for free once every 57 months (3 months before it expires). If you request it before that time, there will be a charge otherwise it is free!
- If you have requested clearances before, login with your previous account. If this is your first time requesting this clearance, click "create individual account"
 - IMPORTANT save your log in info! If you are a mandated reporter, this is the account information you will need if you ever had to report an occurance of child abuse.

Accessing Your Account

- If you know your login information from before, log in and skip to the next step. Otherwise, create individual account.
- If you created a new account, fill in the account information. Remember, you will need to save your username and password to access your clearances in the next 5 years and/or if you are a mandated reporter.
- You will be emailed a temporary password. Close the browser window, open a new window and log in with your temporary password. You can use the link/web address from the previous page in these instructions.

Accessing Your Account

- Click individual log in > access my clearances
- If you just created a log in, you will use your temporary password from the email in this step.
- Once you log in with the temporary password, it will promp you to create your own password. Remember, you will
 need to save your username and password to access your clearances in the next 5 years and/or if you are a mandated
 reporter.
- You will need to log in with your newly created personal password. If you click the 'close' button, it will redirect you to the log in screen



Application Purpose

- Agree to the terms and conditions, click next
- Click continue
- Click Create Clearance Application
- Click Begin
- From the list of application purposes, select the below and fill out the boxes as follows and click next at the bottom of the page.

Volunteer Having Contact with Children: Applying for the purpose of volunteering as an adult for an unpaid position as a volunteer with a child-care service, a school or a program, activity or service, as a person responsible for the child's welfare or having direct volunteer contact with children.

"Individuals submitting an application as a Volunteer Having Contact with Children agree to use the certification for volunteer purposes only. The application fee will be waived if you have not obtained a volunteer certification free of charge within the previous 57 months.
